 - Dynamic Questionnaires and Answer Templates from Question Library
 - API Integration with OCIMF
 - Configurable Vetting Workflow
- Assess and score Risk using Risk Assessment Matrix (RAM)
 - Available on Incidents, Findings and CARs
 - Assign risk matrix by Audit or Incident type
 - Multiple User-defined assessment categories, e.g. Reputation, People, Safety, Environment, Operational

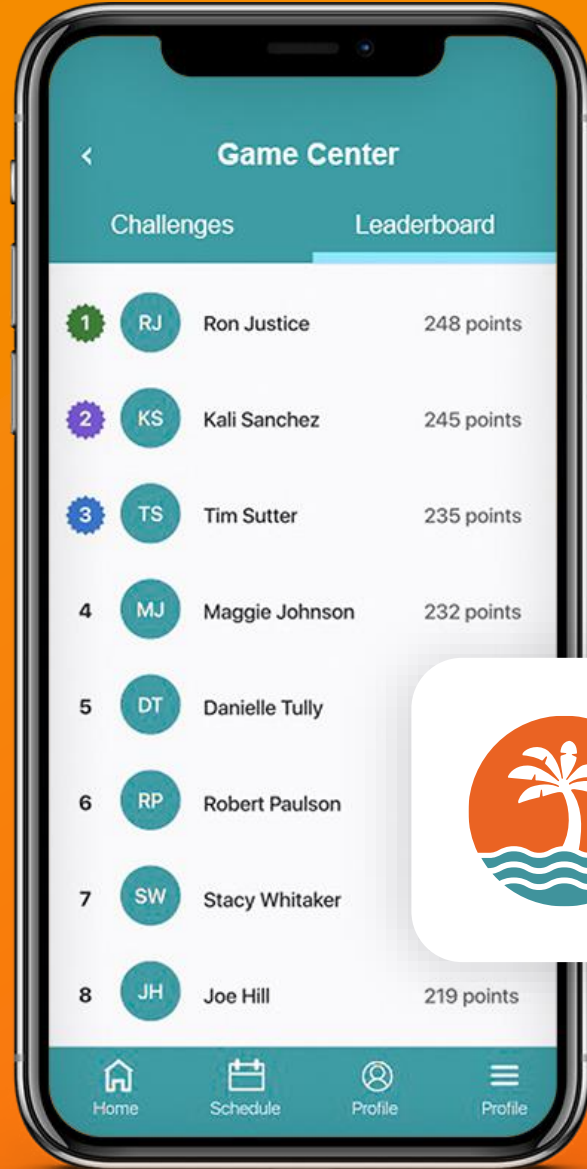
- Questionnaire filtration by Vessel Type
